Online applications are thus invited from the desirous candidates for seeking admission in **Govt. ITI Kathua** for the academic session 2021-22-23 in various Engineering/Non-Engineering Trades having duration of Two years/One year/Six months for **Free & Self- finance seats** being run under NCVT/SCVT Schemes and commencing from September 2021 for which the forms can be uploaded from 16th of July 2021.

The desirous candidates having minimum age of **14 years as on 1st June 2021** with no upper age bar have to fill up the admission forms available online at ITI admission link (<http://itiadmissions.jkdsd.org>) present on the official website of Directorate of Skill Development J&K i.e. www.jkdsd.org.

The last date for applying online is up to **05th of August 2021**. The candidates have to fill up the complete details which include basic details like name, parentage etc. and qualification online in the portal and have to upload the soft copies of the following documents online only:-

1. Marks Certificate of Qualifying examination.
2. Date of birth Certificate preferably 10th class Diploma /Marks Certificate
3. Category Certificate (SC/ST/Ex-serviceman/Physically Handicapped/EWS) if any
4. Aadhaar Card

➤ **(Domicile certificate should be produced at the time of admission in ITI)**

The candidates after finalizing the profile and application online will be required to deposit the print out of the system generated application completed in all respect along with self attested photocopies of documents uploaded on the portal and deposit the prescribed fee of Rs100/- (One hundred only) per three trades against a proper cash receipt in **Govt. ITI Kathua**.

2. Selection will be made purely on the basis of **academic Merit** obtained by the applicants in their qualifying examination (both for free and self financing seats separately).
3. On successful completion of training in trades affiliated under NCVT/SCVT Scheme, Certificates will be awarded by the National /State Council for Vocational Training.
4. Candidates, who have already undergone training in any of the trades of ITIs, can apply for admission in another trade two years after completion of previous training course. However, for the ensuing academic session, their admission can be considered in any trade having poor response.
